BOTH THE BIDS ALONG WITH SEPARATE ENVELOPE FOR BID SECURITY IN SHAPE OF PAY ORDER / BANK DRAFT OR BANK GUARANTEE IN FAVOUR OF PSPC AND TENDER DOCUMENTS MAY BE ADDRESSED TO TENDER OPENING COMMITTEE AND DROPPED IN THE TENDER BOX PLACED AT PSPC FACTORY MAIN GATE ON OR BEFORE ABOVE-MENTIONED DATE & TIME. IN CASE OF HOLIDAY THE BIDS WILL BE OPENED ON THE NEXT WORKING DAY.
